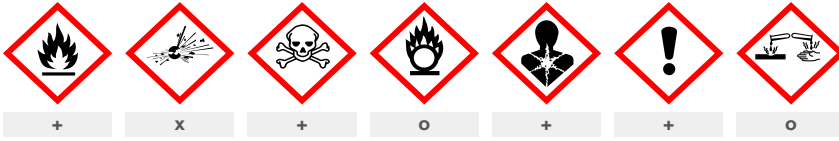

Respiratory protection

The odour may indicate that the mask is not functioning properly, that the vapour concentration is too high, or that the mask is not properly fitted. For thiocarbamates:

Environmental Fate: Thiocarbamates are volatile and will evaporate from soil. They are soluble in water so some leaching and lateral movement is possible. Some photodegradation may occur. There are many environmental factors that influence biodegradation in soil, thus long-term soil contamination is unlikely.

For dithiocarbamates:

Environmental Fate: Dithiocarbamates with hydrophilic groups form water-soluble, heavy-metal complexes, while some of the dithiocarbamate metal complexes used as fungicides are insoluble in water but soluble in non-polar solvents. Alkylene bisdithiocarbamates are insoluble in both water and non-polar solvents. While information on the environmental impact of dithiocarbamates is limited, available data suggest that they are degraded in the presence of moisture, oxygen, etc. to form a number of compounds, some of which are toxic. Dithiocarbamates can be metabolised by soil organisms, but by-products produced in the breakdown process can negatively affect the microorganisms.
